

## EXHIBIT A

### Terms Governing Use of Index Level Data

- 1) Subscriber acknowledges that all proprietary rights in the Indices that are owned by Lehman shall remain the property of Lehman and Subscriber shall have no right or interest in such Indices except the rights to use such Indices upon the terms and conditions of this Agreement. Subscriber acknowledges that the Indices as compiled, prepared, selected and arranged by Lehman constitute an expenditure of substantial time, effort and money by Lehman and constitute valuable commercial property and/or trade secrets of Lehman. Subscriber agrees that it will not remove any copyright notice or other notification or trade name or marks of Lehman that may appear in the Indices and that any reproduction and/or distribution of the Indices shall contain such notices and/or marks as they appear in the Indices. Except as set forth in this Agreement, Subscriber may not use the Lehman Brothers name or trademarks without the prior written consent of Lehman.
- 2) Subscriber agrees that it shall not construct or facilitate the construction of products which compete with the Indices.
- 3) Subscriber shall comply with all applicable laws and regulations relating to use of the Indices during the term of this Agreement.
- 4) SUBSCRIBER ACKNOWLEDGES AND AGREES THAT THE INDICES ARE PROVIDED FOR INFORMATIONAL PURPOSES ONLY. UNDER NO CIRCUMSTANCES SHOULD THE DATA BE USED OR CONSIDERED AS AN OFFER TO SELL OR A SOLICITATION OF ANY OFFER TO BUY THE SECURITIES OR OTHER INSTRUMENTS MENTIONED IN IT. THE DATA HAS BEEN OBTAINED FROM VARIOUS SOURCES, AND LEHMAN DOES NOT REPRESENT THAT IT IS ACCURATE OR COMPLETE AND IT SHOULD NOT BE RELIED UPON AS SUCH. OPINIONS EXPRESSED IN THE INDICES ARE SUBJECT TO CHANGE WITHOUT NOTICE. THE INDICES ARE PROVIDED "AS IS" AND SUBSCRIBER EXPRESSLY AGREES THAT USE OF THE INDICES IS AT SUBSCRIBER'S SOLE RISK. LEHMAN DOES NOT WARRANT THAT THE INDICES WILL NOT BE UNINTERRUPTED, DELAYED OR ERROR FREE, NOR DOES IT MAKE ANY WARRANTIES AS TO THE RESULTS TO BE OBTAINED FROM USE OF THE INDICES.
